Kundan Lal r/o Gurdaspur were running the trust vide trust deed dated 12<sup>th</sup> November, 1996 . Now Sh. Sahil Mahajan S/o Sh. Surinder Mahajan has joined the trust as trustee w.e.f. 31<sup>st</sup> December 2020 and Sh. Ajay Mahajan S/o Sh. Kundan Lal r/o Gurdaspur has resigned from the board of trustees wef 1<sup>st</sup> January 2021 .

And whereas the said Sh. Surinder Mahajan and Sh. Sahil Mahajan are desirous of running the educational institutions as trustees mentioned herein above . Now they feel it necessary and expedient to reduce the rules and regulation upon which the working of the trust has been and shall be carried on into writing.

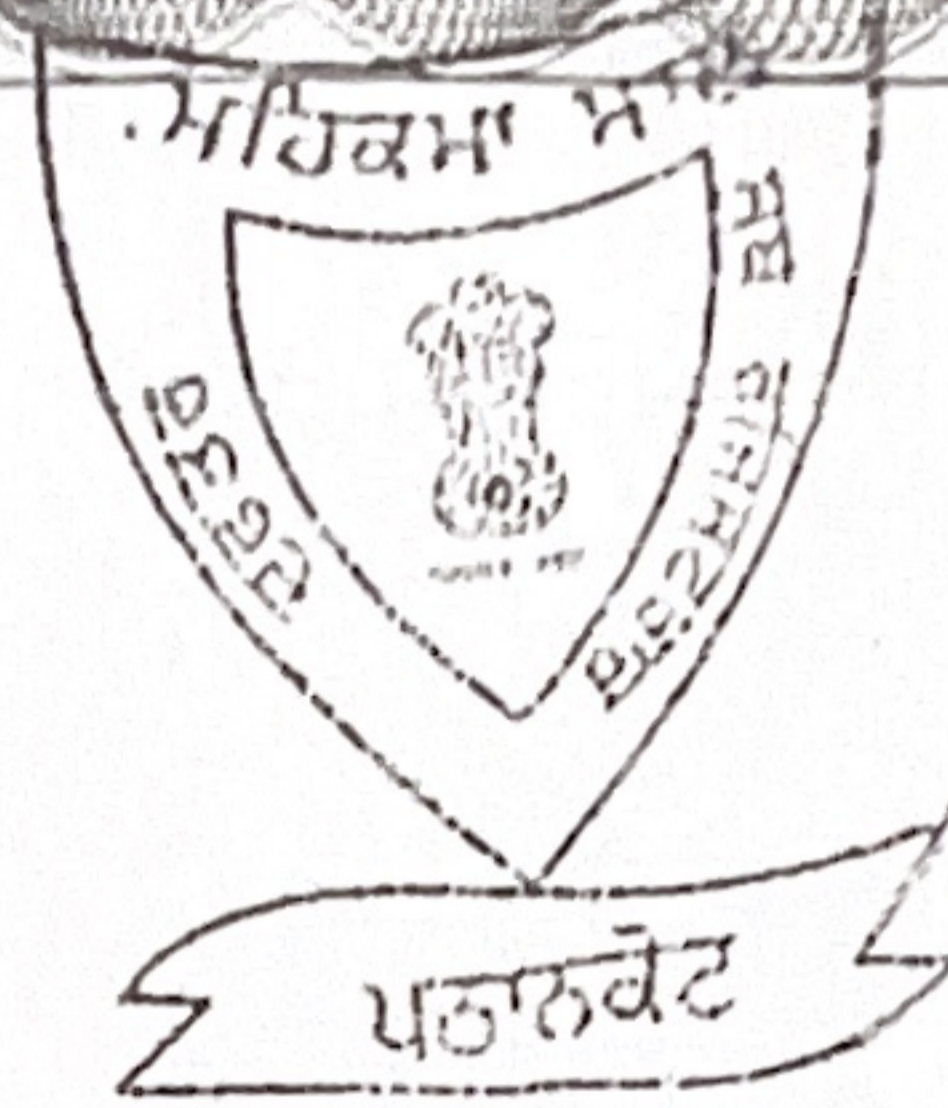

## 2. OBJECTS OF THE TRUST

- (iv) To establish, maintain and run a boarding house and residential institution to the students and those connected with the institution.
- (v) To train and equip and pupils so as to be self supporting in an honorable and decent way of life so as to develop into good, healthy and progressive citizens.
- (vi) To promote and include the dignity of labor, the appreciations of intellectual gifts and talents of all kinds.
- (vii) To encourage sportsman and adventurous spirits in the pupils and those connected with institutions and coming in contact with them and to participate in games of skill and prowess.
- (viii) To bring our, encourage and develop the inventive and research faculties of pupils and teachers and to afford opportunity for research work in art, science and industrial undertakings.
- (ix) To acquire and take over schools and other institutions engaged in the field of education from other, on such terms and conditions as the trust may determine from time to time such rights, concessions, names, properties and assets as may be mutually decided.

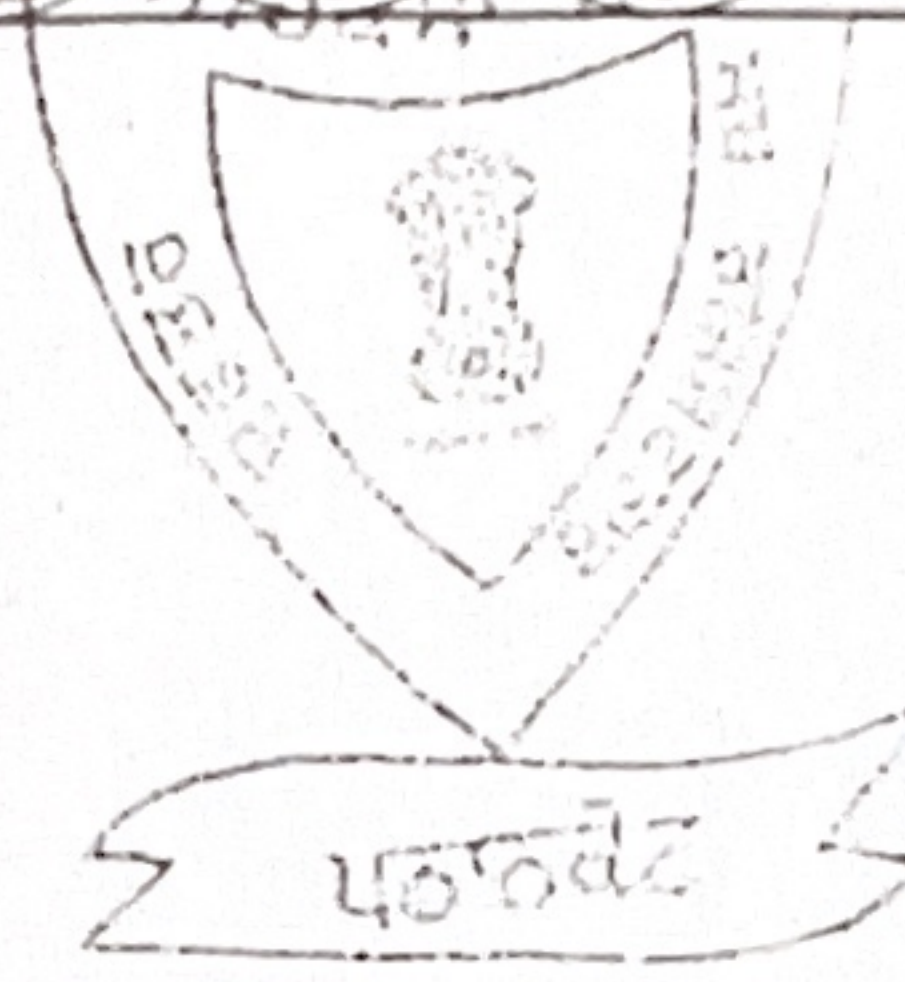

### 3. PROPERTY OF THE TRUST

The founders both hereby set apart a sum of Rs. One lakh only in favour of the trust in shape of cash. The trustees shall hold the said property or other properties movable or immovable that may be endowed or conferred for the said trust for the use and the benefits of the trust. The trustee shall out of the income realized from property endowed and such other endowment or donations which they may get pay all types of expenditure connected with the working of the trust.

### 4. BOARD OF TRUSTEES

- (i) Board of trustees shall consist of the founder Sh. Surinder Mahajan and Sahil Mahajan.
- (ii) In case if vacancy in the office of the trustees by what so ever reason his legal heir will be taken in as trustees.

### 5. POWER AND DUTIES OF THE TRUSTEES.

- (i) The trust may receive donations of money and or properties when received shall be at the absolute disposal of the trust.
- (ii) The trustees may open and operate current or deposit or other account with any scheduled bank and by resolution authorize any one or more of the trustees either singly or jointly operate on such accounts.
- (iii) Trustees shall be entitled to working allowance/remuneration for the services rendered to educational institution (s).

- (iv) The board of trustees may by resolution extend the activities of the trust or undertake any activity in furtherance of the main object of the trust.
- (v) Proper books of account of the trust shall be maintain and shall be audited by the chartered accountant.
- (vi) To do such other lawful things as are incidental in carrying out the administration and management of the trust.
- (vii) The trustees shall maintain the minutes books in which the proceedings of all meeting of the trustees shall be recorded by the trustees.

#### 6. MANAGING COMMITTEE

Trustees may form a managing committee as they feel necessary for better running of educational institution on such terms and conditions and with such members as they deem necessary or as may be required by the appropriate authority from time to time. The term of the managing committee so formed shall be for a period of one year or for such a period as the trustees may decide.

#### 7. CUSTODY OF DOCUMENTS

The trustees or their nominee or any one trustee if so authorize by the board of all the documents, deeds of titles relation to the trust properties and investment and the books of accounts and other records, relating to the trust and shall be responsible for preservation of the same.

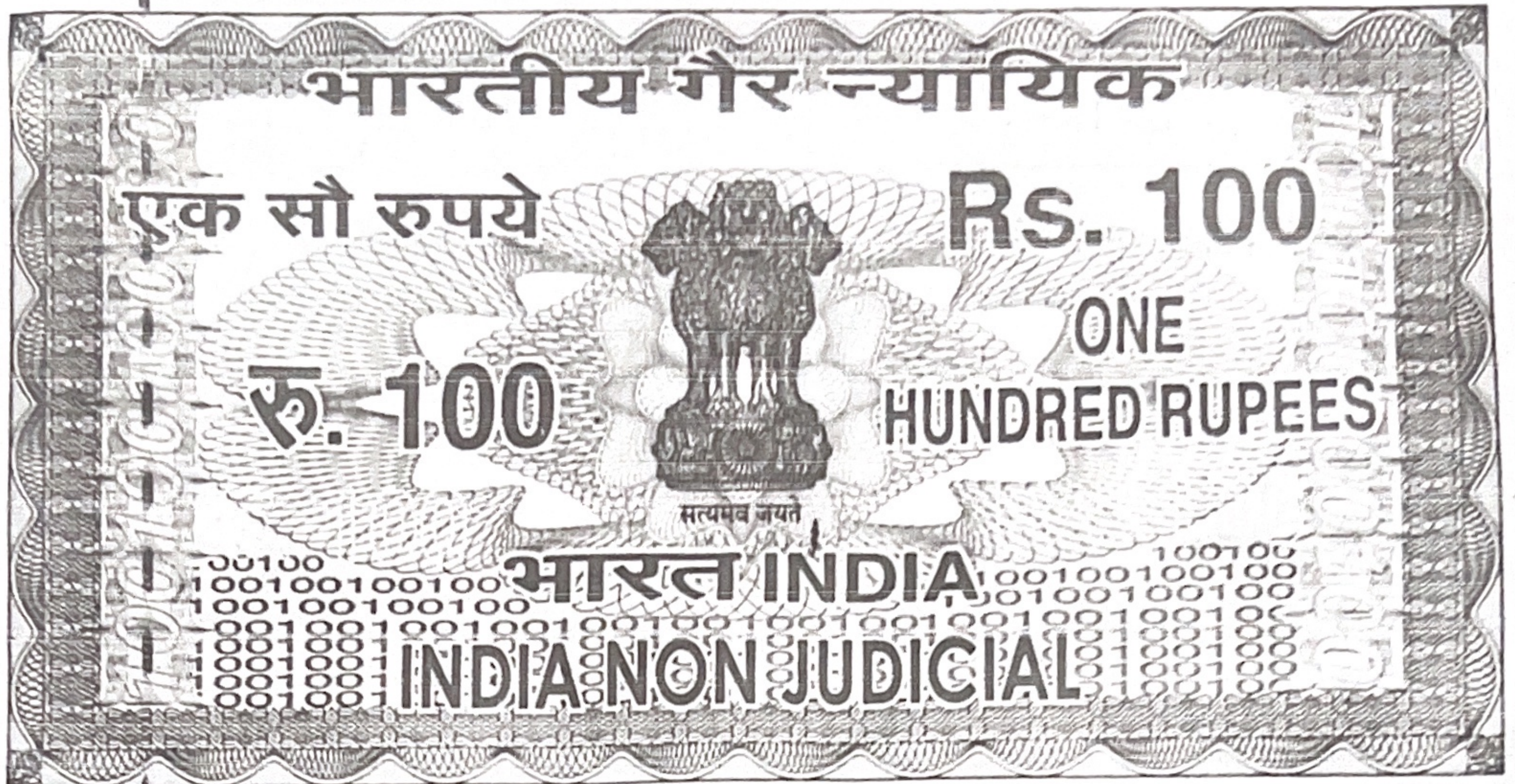

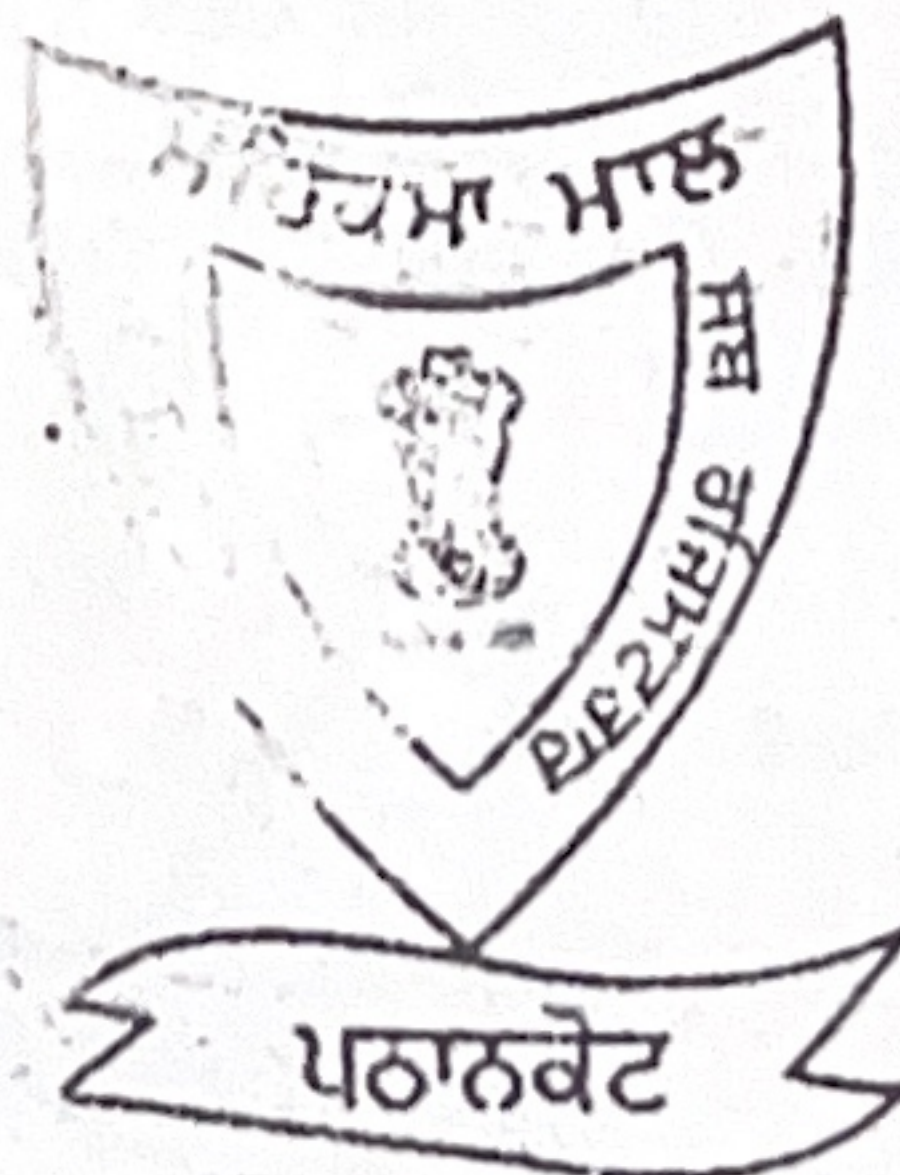

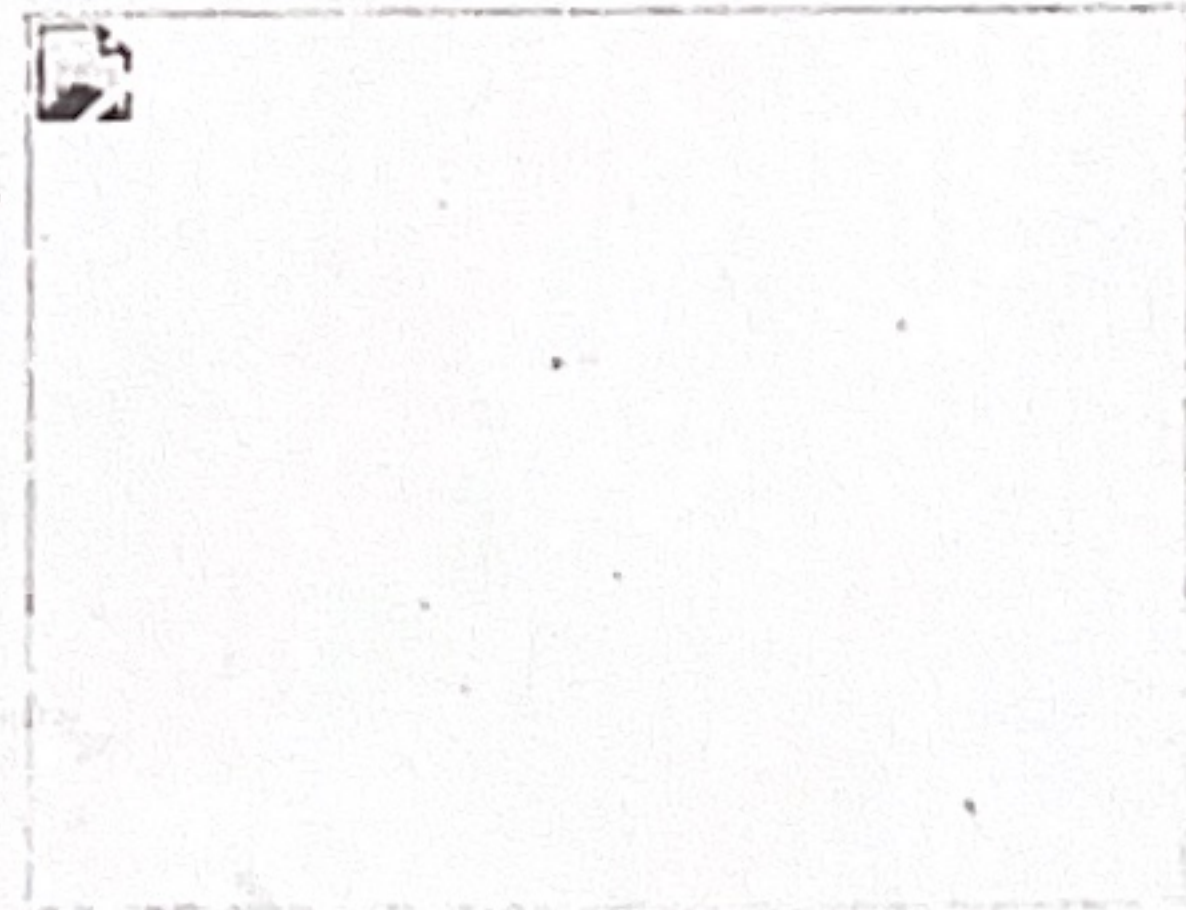
